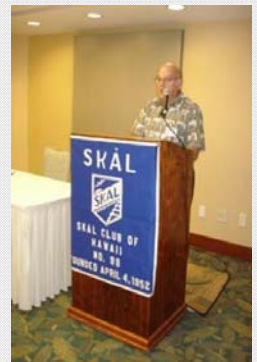

Annual Business Meeting

The Annual Business Meeting on February 24th reviewed a number of areas of our club. Club Treasurer, Mike Miller reviewed the financials and we are glad to report that we continue to stay within budget with assets in excess of \$60,000.

The club is completing its filing to incorporate in the State of Hawaii under Skal International Hawaii with changes to its By-Laws to meet current Hawaii law. We also are making changes to our IRS filing from a 501(c) (7) non-profit/social to a 501 (c)(6) non-profit/business. These changes will allow for a positive foundation to continue to grow Skal in Hawaii in the coming years.



Article 20 of our current By-Laws state that "The election of the Board members, officers and club auditors shall take place at an Annual General Meeting" The elections took place at this meeting by voice vote with slate being elected as submitted.

The revised By-Laws will allow for electronic and mail-in ballots for future elections.

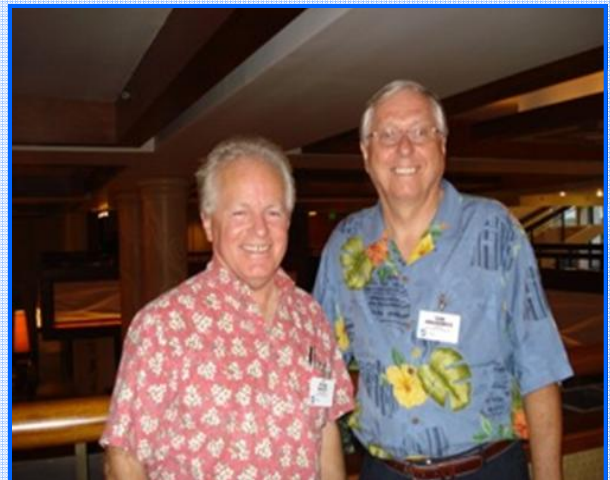

35th Anniversary Hans Strasser

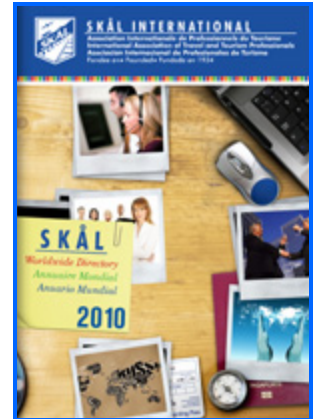
