What is the Florimond Volckaert Fund?

Did you ever wonder about that \$5 you were spending for the lucky number drawing every meeting? No, it's not just so you can potentially win some money, which is always a bonus of course, but those ticket sales actually serve a purpose. To fund our clubs contribution into the Florimond Volckaert Fund. But what is that fund, and why do we pay into it?

The Florimond Volckaert Fund fund was set up in 1954, in the name of the founder of Skål, to provide assistance to Skålleagues and their immediate families who are in serious need of assistance.

How does it work? Well if a Skålleague is ever in need of temporary personal assistance due to a variety of circumstances, the fund is there to provide the Skålleague help. Some past examples of circumstances the Trustees have approved over the years include:

- Loss of job and inability to meet financial obligations.
- Death of a Skålleague whose spouse needs assistance to pay schools fees for their children.
- Cost of surgical / hospital services which cannot be obtained elsewhere.
- Equipment for a physically disabled Skålleague so that the quality of life can be improved.

- Help for members and their immediate families affected by natural disasters.
- Financial assistance because of reduced income or as a result of prolonged illness.

The money for the fund is derived from voluntary donations that come from individual Skålleagues, various Clubs and various Committees.

If you ever find yourself in need of this type of assistance, an application can be sent either through your Club President or International Councillor. There is an approved application form that can be accessed via the Skål website www.skal.org, a copy of which should also be sent to the Trustees. The names and addresses of the current Trustees can be found there as well as in the Skål news.

As a past recipient once said, "In all the years that I was soliciting donations for the FVF, I never dreamed that I would, one day, be asking for help from it." So let's keep those raffle tickets going. This is your Fund. You never know when you may need help, , and if you happen to win a few bucks in the meantime... bonus!

For the record, any assistance given is completely confidential. Unless the recipients want to tell anyone about the help they have received, only the recipients, the sponsors and the Trustees will know.

Membership Renewal Dates and Why They Are Important

Just like tax day and your significant other's birthday, Skål membership renewal comes once per year, and there are consequences (some more dire than others) for missing any of them. The Board thought it might be beneficial to explain the process that happens during the renewal process.

When Naomi gets notice from SIUSA, she sends out the initial reminder email to the Skål International Hawaii membership. In it she gives a deadline for her to get the renewal payments, either by check or by PayPal. To get her deadline dates she is working backwards from the deadline given to her by SIUSA.

She needs a time cushion for two reasons: 1) to make sure that those members who are paying by check – and running the check request through their company's accounting department during the year-end holiday season – have time to get the checks cut and mailed to her, and 2) to reconcile the membership list that SIUSA has with our most current membership list. As you can imagine, both of these activities take a good deal of time and follow up.

The reason it is so important to have an accurate membership list is included in the following from this year's notice to us: "At this point and time, we would like to request that you pay your club's dues to SIUSA by Friday, February 27, 2015. All clubs should remove members who have not paid their 2015 dues from your rosters no later than February 27, 2015. We would recommend that you suspend any unpaid members at that point, as you can always reinstate them later. If this is not done, your club will be responsible for that member's dues for 2015."

We are trying to avoid paying dues for a member who ultimately does not renew, as well as the headache of suspending and reinstating members whose payments did not get in on time. That is why we recommend, if at all possible, that you begin using PayPal for payments of the monthly meetings and renewals. Rack up some airline miles.

If you plan to continue to pay with a check, please be sure to communicate to Naomi (in the response to her meeting invitations, reply "paying by check, request sent to accounting today"), and if possible let her know when the check gets mailed out, so she knows, and doesn't spend time tracking it down. As you know, Naomi has only allotted 20 hours to us each month, and we want to be sure that time is used as productively as possible.
